**APPLICATION FOR ASSOCIATION MEMBERSHIP**

I request to become a member of the Association of Ontario Christian School which is the legal ownership group of the school. I recognize the following to be the duties of the Association:

- 1 Elect members of the Board of Trustees
- 2 Vote to recall members of the Board of Trustees
- 3 Determine whether to approve the annual school general operating budget of Ontario Christian Schools as proposed by the Board of Trustees
- 4 Determine whether to approve the sale, purchase, construction, or alteration of land or buildings valued at more than 2% of the general operating budget
- 5 Determine whether to approve any debt beyond 10% of the annual budget excluding funds for building and capital projects
- 6 Determine whether to approve constitutional changes or dissolution of the Association as proposed by the Board of Trustees

I understand and meet all of the following requirements for Association membership:

- 1 Confess Jesus Christ as my only Savior and Lord and who I regularly worship with a Christian church that holds in preaching and practice all articles of the Apostles Creed.
- 2 Apply and are approved for Association membership by the Board of Trustees
- 3 Promise support and promotion of Article I and pledge not to seek changes in Article I of the constitution that reads as follows.
  - a The mission of Ontario Christian School is to provide and promote a Biblically-based, quality education that nurtures the children of Christian parents to grow in God-centered discipleship, equipped with vision, understanding, discernment, and service in order to renew all relationships and culture to be under the authority of Jesus Christ.
  - b The Association, all instruction, and operations given in its schools are based on the infallible and inerrant Word of God as expressed in the standards of the Reformed/Presbyterian faith (the Heidelberg Catechism, the Belgic Confessions, the Canons of Dort, and the Westminster Confession and Catechisms).
- 4 Make a contribution to Ontario Christian School in this current school year of at least \$250 per year as a donation or by my tuition
- 5 Be at least eighteen years of age and not currently enrolled as a student in Ontario Christian School
- 6 If I have children that would be eligible to attend Ontario Christian, at least one child does attend the school.

I, the undersigned, truthfully confess Jesus Christ as my personal Lord and Savior, agree with Article I of the by-laws of Ontario Christian School, and meet all other qualifications for Association membership.
